2. Minutes of the 1977 A.G.M.

- i) The Minutes of the last A.G.M. were approved without dissent.
- ii) a) The Financial Statement had subsequently been approved by an Auditor.
 - b) Fiona announced that she had had more success than Hilary in persuading people to pay for their Dinner in advance.
- 3. Financial Statement. Because this year's Statement was laid out differently from that of last year, some clarification was made of the "Bank Balance brought forward from 1976/77" figure. It was pointed out that if, on last year's Statement, the "debits" figure was subtracted from the "credits", the amount remaining was the figure which appeared at the top of this year's Statement.

In reply to a question, it was explained that the "creditors" figure in this year's balance represented the auditor's fee, which had not yet been passed through the Club's bank account.

It was also pointed out that, although not explicitly stated, the income from "Highland-77" appeared in the "Event entry fees" item.

4. Amendment to the Constitution. After some explanation from the Secretary, the amendment was proposed by John Barrow, seconded by Fiona Jolly, and with no dissent was carried. A minor amendment, to insert the word "Membership" after "Family", was proposed by Ray Heyworth, seconded by Steve Terry, with no dissent, and was hence carried.
