## **4 Financial Statement for the Year ending 31 March 2023**

Robin introduced the Accounts for 2022/23, which had already been fully audited. He described some of the major aspects of both the Income and Expenditure Account and the Balance Sheet, making reference to the accompanying Notes. The Accounts showed a reasonable surplus. Acceptance of the Accounts was proposed by William Ivory, and seconded by Max Carcas.

John gave a brief summary of the outcome of the recent AGM of British Orienteering, at which a motion was approved to significantly modify the membership structure for 2024. In addition to the normal Categories of Senior and Junior, there would be two new Categories, Young Adult and Family.

A Young Adult would be between the ages of 21 and 25, and would be for both existing and new members. A Family would consist of two Seniors over the age of 25, together with an unlimited number of Juniors living at the same address. John suggested that the Club adopt the same structure and that, as a starting point for discussion, he proposed that the Club fees for Senior and Junior remain the same as at present (viz. £5 and £1), and the fees for a Young Adult and a Family be set at £4 and £12 respectively. The Committee would consider this proposal at its next normal Meeting.

John announced that he intended to relinquish his rôle as Chairman of the ESOA at its forthcoming AGM on 8 November. He also wished to stand down as INT Representative to that Committee.

Paul would continue to be responsible for the Club's equipment.

Graham McIntyre was happy to stay as Webmaster.

It was noted that British Orienteering had stipulated that each Club should have four main Officials, viz. Chairman, Secretary, Treasurer, and Safeguarding Officer. Accordingly, the position currently known as the Club Child Protection Officer (CCPO) would henceforth be known as the Club Safeguarding Officer. This position was currently held by Lucy Galloway.

It was also noted that there would need to be some significant amendments to the Constitution to reflect the functional changes, including that described in the previous paragraph, which had occurred to the remit of some Office Bearers. This had been suggested at the 2022 AGM. The new Committee would be charged with drawing up appropriate wording in time for the 2024 AGM.

## **6 Presentation of "Gullane Rock"**

John read out the citation for this year's award:

"My nominee for this year's award of the Gullane Rock first joined the Club in late 2015. His elder son had joined us somewhat earlier, having been attracted to the sport while at Heriot's. Soon the whole family were to be seen at events.

Within three years, he had been elected on to the Committee as an Ordinary Member. Not long after that, he assumed the role of Events Coordinator, after Pat Squire had stood down and had eventually left Edinburgh for Derbyshire. You will all be aware of my nominee's frequent pleadings for people to volunteer to organise or plan the myriad events of all standards which the Club puts on. A thankless task, I'm sure you'll agree, but one which he undertakes with seemingly boundless energy.

More recently, he and I have managed to arrange for his significant volunteer effort to be rewarded by an arrangement whereby his employer works with an organisation called Benevity Causes, which donates significant sums of money for such effort by members of amateur organisations. In the last Financial Year, this amounted to several hundred pounds for the Club.

I'm sure by now that his identity can hardly be a secret. My nominee for the award of the Gullane Rock for 2023 is William Ivory."
